Dear Parents

The safety and security of the students is of utmost priority to us. As per our earlier circulars, you need to ensure that private vans hired by you to carry your children to the school strictly follow the norms and guidelines as laid down by the Supreme Court. For the safety of your ward, it is reiterated to ensure that:

- Your ward does not travel in illegal commercial vehicles.
- The driver drops your ward to school between -
 - 7:40 am to 7:50 am (**for classes Nursery to V**)
- The driver **picks up** your ward at :
 - 12:45 pm (**Nursery to II**)
 - 1:50 pm (**Classes III to V**)
- Van driver is reliable and has got the police verification done/ renewed.
- Strength of children in the van is reasonable so that they have sufficient space to sit in the van.
- Children are safe while commuting in the van and are not bullied or threatened to do something.
- The authenticity of the documents of the vehicle and the drivers are being cross checked from time to time.
- Drivers follow the safety norms and interact with the school authorities in a respectful manner.

As a parent, you are requested to volunteer to travel in the vans/auto rickshaws on a rotation basis to ensure safe transportation of your children.

We seek your cooperation in this matter as these guidelines are meant for your child's safety.

You are requested to furnish a declaration cum undertaking (as per specimen attached) to the Class Teacher within 3 days of receipt of the circular.
